Impact company informs the shareholders and investors on the fact that in case 9297/111/2010, on the role of Bihor Court, decision 79/2016 was pronounced on the date of 21.03.2016:

„ Admits the exception of lack of locus standi of the applicant Oradea Real Estate Administration, exception raised by the defendant SC Impact Developer & Contractor S.A. and dismissed the action brought by it. It rejects as unfounded the action brought and stated by the applicants the Local Council of Oradea and Oradea City in contradictory with the defendant SC Impact Developer & Contractor S.A. It dismisses the exception of inadmissibility of counterclaim, exception raised by defendants the Local Council of Oradea and Oradea Municipality, dismissed as unfounded the action and counterclaim filed and specified by the applicant counterclaim S.C. Impact Developer

Contractor S.A. in contradiction with the Local Council of Oradea and Oradea Municipality. Offsets the judgment costs of the parties. With right to appeal within 15 days as of communication. ”

Case 9297/111/2010 has as subject matter the action promoted by the Local Council of Oradea and Oradea City and Oradea Real Estate Administration against Impact company to force the company to pay the amount of EUR 1,487,001.60, representing penalties for the joint venture agreement, motivated by the fact that IDC has not completed the homes within the period of 1200 days in accordance with Article 9, letter f of the agreement.
